ARTICLES OF INCORPORATION OF

HEAL THE OCEAN, INC.

A CALIFORNIA PUBLIC BENEFIT CORPORATION

The name of this corporation is HEAL THE OCEAN, INC.

- A. This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.
- B. The specific purpose of this public benefit corporation is to identify sources of near-shore ocean pollution, to work with public agencies to effectuate solutions to the ocean pollution problem, and to educate the public and promote public awareness of ocean pollution and solutions

- A. This corporation is organized and operated exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code
- C. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
